AN ORDINANCE TO ADOPT BY REFERENCE THE MICHIGAN VEHICLE CODE

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:

<u>Section 1. Code Adopted</u>: The Michigan Vehicle Code, 1949 PA 300, MCL 257.1 to 257.923, is hereby adopted by reference.

Section 2. References in Code: References in the Michigan Vehicle Code to "local authorities" shall mean the Township of Chikaming.

Section 3. Notice to be Published: The Township Clerk shall publish this ordinance in the manner required by law and shall publish, at the same time, a notice stating the purpose of the Michigan Vehicle Code and the fact that a complete copy of the code is available to the public at the office of the clerk for inspection.

<u>Section 4. Penalties</u>. The penalties provided by the Michigan Vehicle Code are adopted by reference, provided, however, that the Township may not enforce any provision of the Michigan Vehicle Code for which the maximum period of imprisonment is greater than 93 days.

Section 5. Effective Date. This ordinance was adopted by the Chikaming Township Board at a regular meeting held in the Township Hall on the 8th day of March, 2001, and shall take effect the 16th day of April, 2001, the same being more than thirty (30) days after the date of publication.
