

ORDINANCE NO. 29

CHIKAMING TOWNSHIP ZONING ORDINANCE

AN ORDINANCE TO ESTABLISH COMPREHENSIVE ZONING REGULATIONS FOR THE TOWNSHIP OF CHIKAMING, PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF, IN ACCORDANCE WITH ACT 184 OF THE PUBLIC ACTS OF 1943, AS AMENDED, AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HERewith AND TO PROVIDE PENALTIES FOR THE VIOLATION THEREOF.

The Township of Chikaming, Berrien County, Michigan, Ordains:
