ORDINANCE NO. 50

Adopted: April 12 , 1984

AN ORDINANCE TO DESIGNATE AN ENFORCING AGENCY TO DISCHARGE THE RESPONSIBILITY OF THE TOWNSHIP OF CHIKAMING UNDER THE PROVISIONS OF THE STATE CONSTRUCTION CODE ACT BEING ACT 230 OF THE PUBLIC ACTS OF 1972, AS AMENDED, PERTAINING TO ELECTRICAL INSTALLATIONS WITHIN THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN.

THE TOWNSHIP OF CHIKAMING ORDAINS:

SECTION I

Agency Designated. Pursuant to the provisions of the Michigan Construction Code, in accordance with Act 230 of the Public Acts of 1972, as amended, the electrical inspector of the Township of Chikaming, is hereby designated as the enforcing agency to discharge the responsibilities of the Township of Chikaming under Act 230 of the Public Acts of 1972, as amended, pertaining to electrical installations. The Township of Chikaming hereby assumes responsibility for the administration and enforcement of said Act throughout its corporate limits.


SECTION II
