
AN ORDINANCE TO AMEND ORDINANCE NO. 13 OF CHIKAMING
TOWNSHIP WHICH WAS ADOPTED ON MAY 6, 1965, AS AMENDED.

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:

Section 1. Section 10 of Ordinance No. 13 of Chikaming Township which was adopted on May 6, 1965, is hereby amended by the addition thereto of the following:


Section 10. (m) The Township Board, through the Township Supervisor, may impose temporary restrictions on the use of the public water system when the Water Superintendant, after consultation with the Township's Engineer, determines that the demand for water may exceed the sustained delivery capability of the water system. The Water Superintendant shall make the determination in writing and submit same to the Supervisor together with recommended restrictions. The Supervisor shall take all reasonable measures to inform the system's users of the temporary restrictions including the use of public announcements through the news media. Any water system user who fails to comply with the temporary restrictions, as imposed, upon notification of same, shall be subject to the imposition of a fine not to exceed \$100.00, and the Township shall have the right to shut off water service to any premises that fails to comply with the restrictions.

Section 2. This Ordinance was enacted on the 20th day of August, 1992, by the Chikaming Township Board and ordered to be published in the South County Gazette on the 27th day of August, 1992, being within ten (10) days of its enactment and ordered to be made effective on the 21st day of September, 1992, being more than thirty (30) days after public thereof.
