AN ORDINANCE TO AMEND ORDINANCE NO. 87 OF CHIKAMING TOWNSHIP ENTITLED: AN ORDINANCE TO ESTABLISH COMPREHENSIVE ZONING REGULATIONS FOR THE TOWNSHIP OF CHIKAMING, PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF, IN ACCORDANCE WITH THE PROVISIONS OF THE TOWNSHIP RURAL ZONING ACT, ACT 184 OF THE PUBLIC ACTS OF 1943, AS AMENDED, BY ACT 637, OF THE PUBLIC ACTS OF 1978, AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH AND TO PROVIDE PENALTIES FOR VIOLATIONS HEREOF.

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:

Section 1.

The official zoning map of Chikaming Township, as provided for by Article 24 of the Chikaming Township Zoning Ordinance, is changed and amended to provide the following described parcel of land is zoned R-2, RESIDENTIAL RURAL ESTATE DISTRICT:

That part of the West Half of the Northeast Quarter of Section 29, Township 7 South, Range 20 West, Chikaming Township, Berrien County, Michigan, described as follows: Commencing at the center of said Section 29; thence North, on the North-South Quarter line of said Section 29, 942.4 feet to the place of beginning of the land herein described; thence East 231.5 feet; thence North 550 feet, more or less, to the centerline of Warren Woods Road; thence South 84° 34' West, on said centerline, to the North-South quarter line of said Section 29; thence South on said North-South Quarter line to the place of beginning;  
**Excepting therefrom** that part thereof taken for Highway I-94.

The change shall be made on the Official Zoning Map within ten (10) days after the enactment of this Ordinance as provided by Section 3.01, C., of the Chikaming Township Zoning Ordinance.

Section 2.

Enactment. The foregoing change and amendment to Ordinance No. 87, the Chikaming Township Zoning Ordinance, was enacted on the 11th day of November, 1999, by the Township Board of Chikaming Township, Berrien County, Michigan, and ordered to take effect on the 23rd day of November, 1999, the same being more than seven (7) days after its publication.
