The Consent Agenda was given to the board, Marske moved, Dudiak supported to approve the Consent Agenda.

All ayes, motion carried.

The Treasurer's Report was read by Treasurer Rettig. A motion to approve the Treasurer's report was made by Dudiak, Supported by Marske. All ayes, motion carried.

Paying of the bills was read by Treasurer Rettig. A motion to approve the paying of the bills was made my Marske, supported by Bunte. All ayes, motion carried.

Chief Todd Taylor requested to allow officers Carpp and Alverson to partake in the rifle buy-back program which was approved in 2013 and has been used in the past. A motion was made by Marske, supported by Rettig to allow the officers to partake in the program to be paid back in one (1) year.

All ayes, motion carried.

A motion was made by Marske, supported by Bunte to hire Bradley Miller as a full-time firefighter/MFR starting June 20, 2022, for Chikaming Township Fire Department. All ayes, motion carried.

A request was presented from Greg Nelson, Code Enforcement Officer for Chikaming Township to approve fines relating to the rental program.

A motion to table this request for further clarity and bring back to the Board at their July Meeting was made by Marske, supported by Dudiak

The board approved by a motion from Rettig, supported by Dudiak to approve Special Land Use #210 for Edita Maier at 15256 Lakeshore Road, Lakeside property Code #11-07-0019-0087-02-0 as presented by the planning commission.

All ayes, motion carried.

By Board consensus, the board approved Supervisor Bunte to proceed with discussions with all three libraries regarding monetary expectations and whether a millage for Library funds would be presented on the November election.

A joint meeting for the Elected Park Board and the Board of Trustees was requested at the May Meeting. A motion was made by Marske, supported by Rettig to allow Supervisor Bunte to set a meeting date and advise.
