New Business:

Minor Amendment to Special Land Use Permit 192, by applicant Anna Rafalski Director of Operations of Greenbush Brewing Company. Request that Chikaming Township amend Special Land Use Permit 192 for the purpose of allowing live music to be performed in the Green Bush Annex outdoor beer garden within limits set by Chikaming Noise Ordinance (No 131). Anna told the planning commission that the Greenbush Harvest Party which occurred on September 9, 2017 was an example of the type of music that they would like to book in the future and no noise complaints were filed during the event. The neighbor directly behind the Annex also has no objections.

The board discussed requesting of the Township Board to extend the Red Arrow Green Corridor Moratorium due to the lack of completion of the new revised Zoning Ordinance.

Carlson moved to recommend to the Township Board to extend the Red Arrow Green Corridor Moratorium until March 31 or until after the approval of the new revised Zoning Ordinance. Supported by Rappe. Motion carried unanimously.

Other Public Comments:

Anna Rafalski Director of Operations of Greenbush Brewing Company stated that the current zoning ordinance allows the planning commission to approve minor amendments to Special Land Use Permits. Kohn moved to approve the minor amendment to the existing Special Land Use Permit 192 to allow live music to be performed in the Green Bush Annex outdoor beer garden within limits set by Chikaming Noise Ordinance (No 131).
