Moved by Underhill to approve \$200 for dog park event in June. Items requested will be sent to Alex in the form of a list and he'll order from Amazon. Supported by Sellers. Discussion: Curry talked with TCU at Easter Egg Hunt. \$2,500 from TCU is a follow up from Curry's ask. Ribbons cost \$175, bags of biscuits were purchased at Meijer.

Donation Program Application - Reynolds family tree, township doesn't allow cremated remains.

Moved by G. Taylor to plant tree in honor of deceased daughter, Supported by Ellis.

All in favor: 6, Opposed: 0. Motion Carried.

Park Board Image – Sellers does not want to see board dissolved. We have done amazing things without millage, and our image is damaged outside of meetings. Members need to stay quiet and not discuss negativity with public. When a motion is carried, let it be.

#### **COMMENTS FROM THE PUBLIC:**

Janet Schrader – her comments were not a reflection of who serves but rather how the board is structured, and feels the park board should be an appointed board.

Joseph Reed – waited several months for response, none yet. Is there a timeline as to when Attorney Hilmer will respond? No transparency, and board has ended communication with Reeds. Very unnerving that he hasn't heard back, would like answers and wants to know when he'll hear back.

Underhill responded that Attorney Hilmer is working on letter, FOIA request has taken time.

Josh Higgins -Josh is very proud to be working for us, it's been a productive last 3 years, stairs were destroyed and then fixed, board is progressing.

Fran Wersells - no one is held accountable if board is appointed, please remain elected body.
