TOWNSHIP OF CHIKAMING BERRIEN COUNTY, MICHIGAN

ORDINANCE NO. 45

(Adopted February 11, 1982)

AN ORDINANCE TO AMEND ORDINANCE NO. 41 OF CHIKAMING TOWNSHIP WHICH WAS ADOPTED JUNE 12, 1980.

THE TOWNSHIP OF CHIKAMING ORDAINS:

SECTION I

Section 5.15 (3) of the Uniform Traffic Code for Cities, Townships and Villages previously adopted by this Township on the 12th day of June, 1980, through Chikaming Township Ordinance No. 41, is hereby amended to read as follows:

A person who is convicted of a violation of sub-section (1) or (2) is punishable by imprisonment for not more than 90 days or by a fine of not less than \$100.00, nor more than \$500.00, or both, together with cost of the prosecution.

SECTION II

Section 5.15 b (2) of the Uniform Traffic Code for Cities, Townships and Villages previously adopted by this Township on the 12th day of June, 1980, through Chikaming Township Ordinance No. 41, is hereby amended to read as follows:

A person convicted of a violation of this section may be imprisoned for not more than 90 days or fined not more than \$300.00, or both, together with costs of the prosecution. On a second and subsequent conviction under this section or a local ordinance substantially corresponding thereto, the person may be imprisoned for not more than 1 year or fined not more than \$1,000.00, or both. The Secretary of State, within 10 days after the receipt of a properly prepared abstract, shall record 4 points for each conviction under this Section.

SECTION III

Publication of this Ordinance shall occur within thirty (30) days after its

adoption. This Ordinance shall be in effect thirty (30) days after publication.
