AN ORDINANCE TO AMEND ORDINANCE NO. 87 OF CHIKAMING TOWNSHIP ENTITLED: AN ORDINANCE TO ESTABLISH COMPREHENSIVE ZONING REGULATIONS FOR THE TOWNSHIP OF CHIKAMING, PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF, IN ACCORDANCE WITH THE PROVISIONS OF THE TOWNSHIP RURAL ZONING ACT, ACT 184 OF THE PUBLIC ACTS OF 1943, AS AMENDED, BY ACT 637, OF THE PUBLIC ACTS OF 1978, AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH AND TO PROVIDE PENALTIES FOR VIOLATIONS HEREOF.

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:

Section 1.

The official zoning map of Chikaming Township, as provided for by Article 3 of the Chikaming Township Zoning Ordinance, is changed and amended to provide the following described parcel of land is zoned R-4, RESIDENTIAL MOBILE HOME PARK DISTRICT:

The East 1045.33 feet of the North 300.00 feet of the following described parcel of land: That part of the Northwest Quarter of Section 28, Township 7 South, Range 20 West, Chikaming Township, Berrien County, Michigan, described as follows, to-wit: Commencing at a point on the East and West Quarter line of said Section, North 89° 00' 40" East 33.0 feet from the West Quarter post of said Section; thence North 89° 00' 40" East, along said line, 1274.84 feet to the West Eighth line; thence North 00° 19' 17" West, along said line 1240.80 feet; thence West 172.31 feet; thence North 00° 19' 19" West 541.87 feet (recorded 546.00 feet); thence South 84° 33' 00" West, along the center line of Warren Woods Road, 1111.33 feet; thence South 00° 28' 15" East 33.00 feet East of and parallel to the West line of said Section, 1699.15 feet to the place of beginning.

The change shall be made on the Official Zoning Map within ten (10) days after the enactment of this Ordinance as provided by Section 3.01, C., of the Chikaming Township Zoning Ordinance.

Section 2.

Enactment. The foregoing change and amendment to Ordinance No. 87, the Chikaming Township Zoning Ordinance, was enacted on the 12th day of November, 1998, by the Township Board of Chikaming Township, Berrien County, Michigan, and ordered to take effect on the 1st day of December, 1998, the same being more than seven (7) days after its publication.
