AN ORDINANCE TO AMEND ORDINANCE NO. 87 OF CHIKAMING TOWNSHIP ENTITLED: AN ORDINANCE TO ESTABLISH COMPREHENSIVE ZONING REGULATIONS FOR THE TOWNSHIP OF CHIKAMING, PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF, IN ACCORDANCE WITH THE PROVISIONS OF THE TOWNSHIP RURAL ZONING ACT, ACT 184 OF THE PUBLIC ACTS OF 1943, AS AMENDED, BY ACT 637, OF THE PUBLIC ACTS OF 1978, AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH AND TO PROVIDE PENALTIES FOR VIOLATIONS HEREOF.

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:

Section 1.

The official zoning map of Chikaming Township, as provided for by Article 3 of the Chikaming Township Zoning Ordinance, is changed and amended to provide the following described parcels of land are zoned C, COMMERCIAL DISTRICT:

That part of the Southwest Quarter of the Southeast Quarter of Fractional Section 25, Township 7 South, Range 21 West, Chikaming Township, Berrien County, Michigan, described as follows, to-wit: Commencing at a point on the South line of said Fraction Section 25, 1009.8 feet East of the South Quarter Post of said Section; thence East 50.0 feet; thence North 233.0 feet; thence West 50.0 feet; thence South 233.0 feet to the place of beginning.

Also that part of said Southwest Quarter of the Southeast Quarter of Fractional Section 25, Township 7 South, Range 21 West, described as follows, to-wit: Commencing at a point on the South line of said Fraction Section 25, 1059.8 feet East of the South Quarter Post of said Section; thence East 50.0 feet; thence North 133.0 feet; thence West 50.0 feet; thence South 133.0 feet to the place of beginning.

Also that part of said Southwest Quarter of the Southeast Quarter of Fractional Section 25, Township 7 South, Range 21 West, described as follows, to-wit: Commencing at a point on the South line of said Fraction Section 25, 1109.8 feet East of the South Quarter Post of said Section; thence East 50.0 feet; thence North 141.0 feet; thence West 50.0 feet; thence South 141.0 feet to the place of beginning.

The change shall be made on the Official Zoning Map within ten (10) days after the enactment of this Ordinance as provided by Section 3.01, C., of the Chikaming Township Zoning Ordinance.

Enactment. The foregoing change and amendment to Ordinance
No. 87, the Chikaming Township Zoning Ordinance, was enacted on the
