An email was received with information on tracking the Bill for the 2019 Trust Fund Grant MDNRT. A bill has been introduced in the Senate Appropriations Committee.

Carson also desires to be involved with our water rescue team.

Chief Davidson ask the board to reinstate Tobin Klint to the fire department. Toby started with the fire department in February 2005 became certified firefighter I & II and a licensed MFR. He was active until 2010 when he resigned to start his carrier in the medical field. A motion was made to reinstate Tobin Klint by Sullivan supported by Marske.
