Our first concert in the park (HCP) has been confirmed for Saturday July 29<sup>th</sup>, Edgar Willbury Experience performing from 5-7, two or three food trucks will be placed on the former dugout concrete pads and in front of the concession area.

The backup first responder vehicle will be sold by a bid process agreed upon by the township. All ayes, motion carried.

A motion was made by Marske, supported by Rettig to accept the estimate from D. Layman Construction, LLC for repairs to the fire station roof and doors in the amount of \$5,057.11. All ayes, motion carried.

A motion was made by Dudiak, supported by Marske to approve an application and permit from Ace Pyro, LLC for Fireworks for July 3, 2023 at Chikaming Country Club. All ayes, motion carried.

A motion was made by Marske, supported by Bunte to approve a resolution for a request of a speed Study on Warren Woods Road from Lakeside Road to Chikaming Park and Preserve.

A request was submitted for an on-premises tasting room for Fulcra Brewing Company, LLC. A motion was made by Marske, supported by Rettig to approve the on-Premises Tasting Room Permit to the Michigan Department of Licensing and Regulatory Affairs Liquor Control Commission.

A motion was made to approve a request to re-zone 4 properties, 11-07-0020-0042-04-0, 11-07-0020-0042-05-8,11-07-0020-0042-06-6 and 11-07-0020-0042-07-4 from R-1 single family to RE-Recreation by Marske, supported by Dudiak.

A motion was made by Dudiak, supported by Rettig to approve a Parcel Combination to create a conforming lot for Property ID 11-07-4570-0055-00-1 and 11-07-4570-0046-00-2 to Robert & Jennifer Linton.

A motion was made by Marske, supported by Rettig to accept a bid from Sawyer Garden Center for landscaping in downtown Sawyer after the resurfacing with the new curb cuts and planting areas. Cost of \$12,595.15.

A motion was made by Marske, supported by Sullivan to approve the amending of Ordinance 126. Removing the park board from the ordinance and replacing it with the Parks Director and Supervisor for the approval process for access to the beaches.

# DISCUSSION TOPIC: NEW BUFFALO TO BRIDGMAN AEP TRANSMISSION LINE REPLACEMENT

Approximately 60 people came to voice their opposition to the Transmission Replacement through Chikaming Township.

Several comments with concerns of the poles and placement of them taking down trees and landscaping along the route, along with questions as to what will happen to the path put in by the county, will it be on that side or the road or to the other side, then being placed in Harbert Park. None of these questions could be answered by the township until discussion hopefully with AEP representatives.

There has been no communication from AEP or word on public until today. Several residents received three-page question and answer sheet they received from Eric Giffey, Project Outreach Specialist for Indiana Michigan Power and asked to post it during the meeting for the public to read.

A concerned resident advised there was a rumor of a meeting on June 29<sup>th</sup> for the public at Froehlich's in Three Oaks. It was confirmed during the meeting that it will take place.
