NEW BUSINESS:

The Pier Street beach access will be closed indefinitely due to the rising lake waters and erosion. It is a danger for our residents. Chikaming Township Park Board will be posting signs very soon.

A motion was made by Sullivan, supported by Marske to accept a bid from Pontem software for CM Data Manager with Integrated Imaging software in the amount of \$2,625.00 for our cemeteries along with future updates and annual maintenance fee of \$420.00.

A motion was made by Dudiak, supported by Marske to allow Supervisor Bunte to advise the County Treasurer that from the foreclosed list sent to Chikaming Township there are no properties we feel need to be demolished.

All ayes, motion carried.

A motion was made by Marske, supported by Sullivan to add a discussion topic to the Township Boards agenda starting at our June 2019 meeting. All ayes, motion carried.

COMMENTS FROM THE PUBLC:

John Krsul, employed by Pokagon Fund advised that if we were not aware, Janet Cocciarelli, resigned as Executive Director of the Pokagon Fund effective June 7, 2019. As they continue to look for an executive director, John will manage the office and Kaaren Cass will continue to maintain the grant writing. If we should need anything he will be of assistance.
