1. Library Services Contract:

2. Dangerous Buildings Follow Up:

A motion was made by Marske, supported by Dudiak to proceed with enforcement Section 7 of our Ordinance #78 for properties at 7312 Harbert Road and 5084 Browntown Road.

NEW BUSINESS:

1. Fire Chief Retirement

A motion was made by Dudiak, supported by Marske to accept Fire Chief Mike Davidson's letter of retirement and work with him on his succession plans. All ayes, motion carried.

2. Road Name Change Request

A letter was presented to the Board regarding First Road requesting that First Road be renamed Daisy Lane, there are five (5) "First" roads in the Township. Motion was made by Dudiak, supported by Sullivan to approve the request.

3. Zoning Application Fees

A motion was made by Marske, supported by Bunte to increase the Zoning Board of Appeals application fee from \$500.00 to \$1,000.00. Due to the current cost of a permit not covering the actual cost.

4. Township Employee Healthcare Plan Renewal

A motion was made by Marske, supported by Sullivan to approve the annual 2022 Health Care Plan and continue with Blue Cross Blue shield for our township employees and their families with staff absorbing a slight premium increase.

A motion was made by Marske, supported by Sullivan to approve an Electronic recycling date of June 8th, 2022 from 3-8 including household hazardous waste and electronic items with Chikaming township being the host for the County.

DISCUSSION TOPIC: House Bill 4722 (H-11) on Short Term Rentals

The proposed House Bill #4722 on Short Term Rentals could impact our township. The bill states that a local unit of government may limit the total number of units used for short-term rental in the local unit. The limit shall not be less than 30% of the number of existing residential units in the local unit of government and shall apply without regard to the location of dwelling units. Neighborhoods could be overrun with vacation rental properties. Chikaming Township has 4088 residential properties, giving a possibility of 1200 rental units being allowed in our community.

This would be substantially higher than our current amount of approximately 468 rental properties.

Several people commented regarding their concerns, driving up housing prices and with the need of affordable housing already this would create more problems.

Supervisor Bunte advised everyone to contact our Senators immediately with no time limit it is imperative to act quickly.
