Not only has the Program helped millions of families, but the techniques and technologies developed by it over the years helped launch today's home performance industry. The Program's primary purpose, is "...to increase the energy efficiency of dwellings owned or occupied by low-income persons, reduce their total residential energy expenditures, and improve their health and safety, especially low-income .

Reduce Energy Bills and Save Money

Reduce energy costs for low-moderate income families by improving the efficiency of their homes.

- High energy costs are an excessive burden on low-income families.
- By lowering energy bills families, increases their self-sufficiency.
- Weatherization measures are delivered to single-family homes and mobile homes.
- The Weatherization Assistance Program primary goal is to reduce the home energy costs.



The Weatherization Assistance Program is funded by the U.S Dept. of Energy, State of Michigan Bureau of Community Action and Economic Opportunity, and administered by Southwest Michigan Community Action Agency.

Save Energy, Safeguard Health and Safety

Agencies install cost-effective measures to reduce home energy consumption .



- Weatherization technicians use energy audits to determine which energy efficiency measures are more appropriate and cost-effective for each home.
- Typical measures may included attic, wall, basement insulation, door sweeps/weather stripping, window air sealing or caulking, LED bulbs, furnace repair/replacement, programmable thermostat and continuous ventilation fan.
- Weatherization Contractors also address energy-related health & safety conditions, particularly carbon monoxide and combustion safety.
